

Completing the Minor Waiver for Unaccompanied Minors

For use when a minor participant will be on property without a parent or legal guardian present. Both pages must be fully completed, signed, and notarized before arrival.

**IMPORTANT**

Do not sign the waiver until you are in front of a notary.
Both pages must be completed, signed, and notarized before the minor arrives at AMP.

PAGE 1

PARENT / LEGAL GUARDIAN WAIVER

1**ENTER EVENT INFORMATION**

At the top of Page 1, under Description and Location of Event(s), write the planned activity, "Atlanta Motorsports Park," and the date you will be on property — not the date you are filling out the waiver.

e.g. Karting at Atlanta Motorsports Park on 7/4/2027

2**READ THE ENTIRE WAIVER**

The parent or legal guardian should read the full agreement carefully before completing the signature section.

3**SECTION 1 — FIRST PARENT / LEGAL GUARDIAN**

The first parent or legal guardian completes the following:

- Signature
- Printed name
- Date of birth
- Affiliation (if applicable)

SECTION 2 — SECOND PARENT / LEGAL GUARDIAN

If available, the second parent or legal guardian completes the following:

- Signature
- Printed name
- Date of birth
- Affiliation (if applicable)

SIGN IN FRONT OF THE NOTARY

Each parent or legal guardian must sign and date the form while the notary is present. Do not sign beforehand.

NOTARY COMPLETES PAGE 1

The notary will complete the Subscribed and Sworn section, including:

- Notary signature and date
- County and state
- Commission expiration date
- Notary seal

PAGE 2

MINOR PARTICIPANT WAIVER

ENTER EVENT INFORMATION AND DATE

At the top of Page 2, under Description and Location of Event(s), write the planned activity, "Atlanta Motorsports Park," and the date you will be on property — not the date you are filling out the waiver.

HAVE THE MINOR READ THE WAIVER

The minor participant should read and understand the full agreement before signing.

COMPLETE THE MINOR'S INFORMATION

Enter the following for the minor participant:

- Signature
- Printed name
- Date of birth
- Affiliation (if applicable)

10 MINOR SIGNS IN FRONT OF THE NOTARY

The minor must sign and date the form while the notary is present.
Do not have the minor sign beforehand.

11 NOTARY COMPLETES PAGE 2

The notary will complete the remaining notary section, sign the form, and apply the notary seal.

12 REVIEW BOTH PAGES BEFORE SUBMITTING

Confirm the following before bringing the document to AMP:

BEFORE SUBMITTING — CONFIRM ALL:

- ☐ Every applicable blank is completed
- ☐ All required signatures and dates are included
- ☐ Both pages contain the notary's signature and seal
- ☐ All information is clear and legible

13–14 BRING TO THE AMP FRONT GATE

Present the completed document to the Front Gate Attendant upon arrival.
The attendant will verify all information and retain the document for our records.
